

At our recent AGM we were delighted to present Mitcham Cricket Club with its official certificate showing that the cricket pavilion is an Asset of Community Value. This important designation – the first in Merton – gives the cricket pavilion a range of important protections. Contracting out the management of green spaces

You may have heard that Merton Council plans to contract out the maintenance of its green spaces. It has bundled this contract alongside one to contract out the borough's waste services.

We have a number of concerns about both the process and the outcome. We are not alone. Merton's green spaces benefit greatly from the involvement of volunteer Friends' groups, community groups and others who work hard to look after them.

This is not 'just' about litterpicking, important though that is. It is also about much more intensive work too, such as maintenance of plants and open spaces. Many people have said they would reconsider involvement in this kind of activity if it were in support of a commercial enterprise rather than the local council. The loss of both goodwill and valuable effort from local people would be a severe blow to open spaces management across our borough.

Just as important as the value of volunteer work is the accuracy of the specification of work in any contract. This needs to take account of the particular needs of specific areas as well as being sensitive to different types of open spaces. As a result of discussions with Merton Council we have been told that we – and other groups – will be given sight of the final specification in order to make input to it.

We have met with other organisations across Merton which share our concerns, including the locally based Friends of the Canons and Mitcham Society. A new independent Greenspaces Forum is being considered to work on this important issue in the hope of securing the best outcome possible for our valued green spaces. This is very much a 'live' topic so please let us know if you want to be kept informed.

Brook House on Cricket Green is in the process of being converted into 46 flats. There is no new building work, and under Government legislation offices can be converted to flats without seeking planning permission in most cases.

We are **changing the start time of our regular monthly meetings** for the next few months. Up to and including our August meeting we will start at 7pm instead of 6pm. This is an experiment to see if people who work during the day will find the later start more attractive. Please join us if you can. We meet on the last Tuesday of every month, at the Cricket Pavilion. More details on the back page and at our web site.

The Canons Lottery bid update

You will recall from our last Bulletin that we are working with Merton Council, Friends of the Canons and Mitcham Society as the Canons Partnership on a Lottery bid for The Canons and its grounds. We secured 'Stage 1' funding and are working on detailed proposals for just shy of $\pounds 4$ million being invested in the area.

We had hoped a Project Manager and Community Engagement Officer would be in post by now, but the Council wheels turn slowly. By the time you read this the posts may have been advertised, but the timescale for this project is not open ended. The final bid needs to be with HLF by the middle of next year. We have already put in a lot of volunteer time behind the scenes and are happy to continue to do this and support a project which could dramatically change our area for the better. But Merton Council, as the owner of the bid, must lead on moving it forward.

Burn Bullock update

In our last Bulletin we passed on the information that the Burn Bullock has been added to the national Heritage at Risk Register – a record of listed historic buildings and structures across England most at risk from being lost or irrevocably damaged.

Merton Council required the owner to submit a planning application to repair the listed building, and permission was granted in March for a range of internal and external repairs. Further information on the Tudor parts of the building has been requested by English Heritage and permission to work on these held back pending the submission of a report by the applicant. The repairs are required to be completed within five months of the approval date of 3 March 2015 – i.e. by 3 August 2015. Watch this space!
